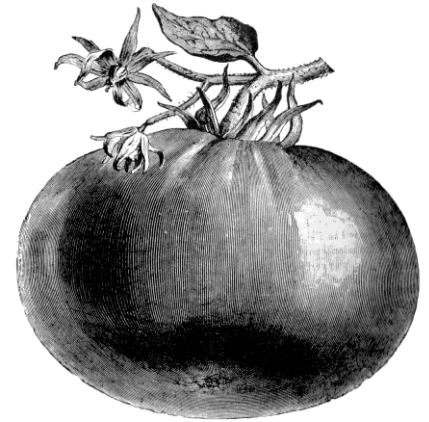


TWIN TOWNS GARDENERS' MARKET

INFORMATION AND VENDOR APPLICATION



The Twin Towns Gardeners' Market Organizing Committee is now accepting applications for our **seasonal seller program**. Seasonal sellers are guaranteed a space at the weekly market, and can attend every week for one flat rate. Farm names and types of goods brought to the market by each seller will also be included in some market publicity to inform shoppers about who they can buy from and what they can expect to find from week to week.

As a seasonal seller, you are also automatically a member of the North Dakota Farmers' Market and Growers Association (NDFMGA). NDFMGA members receive a free roll of 100 "Dakota Grown" logo stickers, free use of the NDFMGA logo, discounts on other promotional and packaging materials, invitations to educational opportunities, quarterly NDFMGA newsletters, placement on the NDFMGA website, and more.

The price of a **seasonal seller membership is \$40**.

Market information:

The market will begin in mid-June or early July. The market will run from 4:00 to 7:00 p.m., with set-up beginning at 3:00 p.m. The market will run on subsequent Thursdays for the remainder of the season, which is tentatively set for the end of September.

Other ways to sell:

Though we encourage serious growers to commit to a seasonal seller membership to take advantage of increased publicity and NDFMGA benefits, we also have a **weekly seller** program for those who may not be able to commit for an entire season, or who wish to test the waters first. Weekly seller fees are \$15 and space is allocated on a first-come, first-served basis. Contact Penny at 701-642-2392 for more information.
